Introduction

Kintra Wealth, LLC ("Kintra") is registered with the Securities and Exchange Commission as an investment adviser. Brokerage and investment advisory services and fees differ and it is important for you to understand the differences. What investment services and advice can you provide me?

Kintra provides personalized investment management and financial planning services. Clients advised include individuals, families, trusts, charitable organizations and foundations, pensions and corporations. Kintra does not impose a minimum fee or amount of assets to be placed under management to work with the Firm

Financial Planning

Kintra may provide its clients broad or focused financial planning and consulting services on topics including but not limited to Investments, Insurance, Education Funding, Budgeting, Estate Planning, Tax Minimization, and Retirement.

Asset Management

When we perform asset management services, we will do so on a discretionary basis. This means that while we will continue an ongoing relationship with each client, being involved in various stages of their lives and decisions to be made, we will not seek specific approval of changes to the securities in client accounts. In very limited cases, Kintra provides investment management services on a non-discretionary basis, which means we will manage the clients' accounts as we do for our discretionary clients, except we will consult with the client prior to implementing any investment recommendation. Clients should be aware that some recommendations may be time-sensitive, and, as such, their performance may be affected if Kintra is unable to reach them on a timely basis. Each client's portfolio is monitored and invested according to their investment objectives, determined through document reviews, interviews, and written objectives. EWS develops a portfolio to best fit the client's needs, considering all accounts and the impact of investments on each. Asset management services are provided on a household basis. We may recommend that you use the services of a third party money manager to manage all or a portion of, your investment portfolio.

What fees will I pay?

Financial Planning

Clients engaging the Firm for financial planning services may do so on an hourly basis. The hourly rate ranges from \$200 to \$400 per hour. These fees are guidelines, subject to change according to the complexity of the plan and the specific client's circumstances, as some clients have more challenging issues than others. These complexities may not necessarily correlate with greater net worth. Financial Planning fees will be due upon receipt of invoice from Kintra

Asset Management

Kintra provides investment management services for an annual fee based upon a percentage of the assets being managed by Kintra. This asset based fee typically varies between 1.25% and 0.40% depending on the amount of assets under management. Fees are negotiable, and may be higher or lower than this range, based on the nature of the account. Factors affecting fee percentages include the size of the account, complexity of asset structures, and other factors. Investment advisory fees will be debited directly from each client's account. The advisory fee is paid monthly, in arrears, based upon the market value of the assets being managed by Kintra on the last day of the previous billing period as valued by the custodian of your assets. There are a number of other fees that can be associated with holding and investing in securities such as transaction fees for the purchase or sale of a mutual fund or Exchange Traded Fund, or commissions for the purchase or sale of a stock. All other fees will be deducted from your account. Expenses of a fund will not be included in management fees, as they are deducted from the value of the shares by the mutual fund manager. In addition to the annual asset management fee, Clients who accounts are covered under certain service provider agreements will pay an additional "Platform Fee" to Advisor for additional services rendered. The Platform Fee covers additional costs associated with the programs for services such as overlay management, enhanced trading tools, reporting (e.g., manager and portfolio reports), expert support, platform management (e.g., ongoing product development and administration) and additional operational and support related functions. This fee is assessed in the same manner and payment as the annual advisory fee.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you.

Certain professionals of Kintra are separately licensed as independent insurance agents. As such, these professionals may conduct insurance product transactions for Kintra clients in their capacity as licensed insurance agents, and will receive customary commissions for these transactions in addition to any compensation received in their capacity as employees of Kintra. These professionals therefore have incentive to recommend insurance products based on the compensation to be received, rather than on a client's needs. Clients should be aware of this conflict when considering whether to engage Kintra or utilize these professionals to implement any insurance recommendations. Kintra attempts to mitigate this conflict by requiring that all investment recommendations have a sound basis for the recommendation, and by requiring employees to acknowledge their fiduciary responsibility toward each client.

Depending on a client's given circumstances, Kintra may recommend that a client rollover retirement plan assets to an Individual Retirement Account (IRA) managed by us. As a result of a rollover, we may earn fees on those accounts. This presents a conflict of interest, as Kintra has a financial incentive to recommend that a client roll over retirement assets into an IRA we will manage. When we provide investment advice to you regarding your retirement plan account or individual retirement account, we are fiduciaries within the meaning of Title I of the Employee Retirement Income Security Act and/or the Internal Revenue Code.
